ORDER:-

In Government order first read above the Government have sanctioned a sum of Rs.235.00 crore to Health and Family Welfare Department from the Member of Legislative Assembly Constituency Development Scheme (MLACDS) Fund for the year 2020-21 for procuring medicines and materials to defect and contain COVID - 2019. Out of the above sanctioned amount so far a sum of Rs.169.6185 crore have been utilized. Balance available imount is Rs.65.33 crore.

2. Now, based on the decision taken of meeting on the funds sanctioned and availability for COVID-19 relief measures in the Government order second read above. The Director of Medical Education, Director of Medical and Rural Health Services and the Engineer-in-Chief (Buildings) and Chief Engineer (Buildings) X1500

- Chennai Region, Public Works Department, Chennai in their letter third to fifth read above, have sent the proposal requesting the Government to accord necessary administrative and financial sanction towards Civil and Electrical works for providing Oxygen pipelines/Outlet points, Mani-folding room arrangements for oxygen cylinders, providing Liquid Oxygen Plant Platform arrangements, Minor civil and Electrical Corona works.
- 3. The Engineer-in-Chief (Buildings) and Chief Engineer (Buildings), Chennai Region, Public Works Department, Chennai has stated the works relating to Oxygen Lines and Minor Civil and Electrical repairs amounting to Rs.135.41 crore for Corona related works not covered in G.O.(Ms.).No.248, Health and Family Welfare Department, dated 17.06.2020. Further, as 40% of the works have already completed and 30% of the works are in progress are napring completion and the contractors are asking for payment. He has requested the Government to issue necessary administrative and financial sanction for a sum of Rs.135.41 crore for the above works. He has furnished the rough cost estimate prepared by him duly countersigned by the Director of Medical Education and the Director of Medical and Rural Health Services.
- 4. The Government, after careful examination of the proposal of the Engineer-in-Chief (Buildings) and Chief Engineer (Buildings), Chennai Region, Public Works Department and accept the same. Acceldingly, the Government hereby accord administrative and financial sanction for a sum of Rs.135.419 crore (Rupees One hundred thirty five crore forty one lakh and nine thousand only) for which Rs.65.33 crore (Rupees Sixty five crore and thirty three lakh only) from the Member of Legislative Assembly Constituency Development Scheme (MLACDS) fund and Rs.70.089 crore (Rupees seventy crore eight takh and ninety thousand only) from State Disaster Response Fund (SDRF) for Civil and Electrical works for providing Oxygen pipelines / Outlet points, Mani-folding Room arrangements for Oxygen Cylinders, Liquid Oxygen Plant Platform arrangements, Minor Civil and Electrical Corona works in Government Medical Institutions.
- 5. The expenditure sanctioned in para 4 above shall be debited to the following head of account.

The Chief Engineer (Building)/Commissioner of Revenue Administration is also requested to include this expenditure while sending the budget proposals for RBE/RE/FMA 2021-22 and draft explanatory notes for Supplementary Estimates 2021-22 to Government in Finance (BG-I/Revenue/Health-II) Department without fail.
