ORDER:

The Honourable Chief Minister of Tamil Nadu has made the following announcement on 03.06.2021.

“கொரோனா தொற்று காலத்தில் களப்பணியாற்றிவரும்
1 இலட்சத்து 17 ஆயிரத்து 184 சாவல்துறையினருக்கு ரூபாய் 5 ஆயிரம்
ஊக்கத்தொகை வழங்கப்படும்”

2. Based on the announcement, the Director General of Police has sent proposal to Government wherein it has been stated that considering the role of police personnel in the pandemic management and in order to maximize their efficiency and at the same time to motivate the police force in their ordeal function in discharging their duties, the Director General of Police has requested to sanction a sum of Rs. 58,59,20,000/- (Rupees Fifty eight crore fifty nine lakh and twenty thousand only) to grant Rs.5,000/- (Rupees five thousand only) as incentive to all police personnel from the rank of Grade II Police Constables to Inspectors of Police.

3. After detailed examination, the Government accept the above proposal of the Director General of Police, Chennai. Accordingly, the Government hereby accord sanction for a sum of Rs. 58,59,20,000/- (Rupees Fifty eight crore fifty nine lakh and twenty thousand only) towards grant of Rs.5,000/- (Rupees five thousand only) as incentive to

all police personnel from the rank of Grade II Police Constables to Inspectors of Police.

4. The expenditure sanctioned in para 3 above shall be debited to the following Head of Account under Demand No.51.01 -- Relief on account of Natural Calamities

2245 – Relief on account of Natural Calamities – 80 General – 800 Other Expenditure – State's Expenditure – AH Disaster Preparedness / preventive measures to contain the outbreak of Corona Virus (Covid-19) – 309 Grants-in-Aid-09 Others

(IFHRMS DPC 2245 80 800 AH 30909)

5. Necessary additional provisions of Rs.58,59,20,000/- will be provided in RBE/Revised Estimates / Final Modified Appropriation 2021-2022. Pending provision of such additional provisions, the Commissioner of Revenue Administration and Disaster Management is directed to draw and disburse the amount sanctioned in para 3 above to the Director General of Police based on the requirement received from the Director General of Police. However the above expenditure shall be brought to the notice of the Legislative Assembly by specific inclusion in the Supplementary estimates 2021-2022. The Director General of Police is directed to furnish the Utilisation Certificate to the Commissioner of Revenue Administration and Disaster Management after disbursement of incentive to all the eligible Police Personnel. The Commissioner of Revenue Administration and Disaster Management is directed to send necessary proposals to Finance (BG.I/Revenue) Department at appropriate time for inclusion of the expenditure sanctioned in para 3 above in the Supplementary Estimates with explanatory notes/ Revised Estimates / Final Modified Appropriations 2021-2022.

6. This order issues with the concurrence of the Finance Department, vide its U.O.No.25099/Home-I/2021, Dated.18.06.2021 and Additional Sanction Ledger No.149 (One hundred and forty nine).
