The Government also ordered that, the Additional Chief Secretary/ Commissioner of Revenue Administration has been appointed as the State Nodal Authority to authorize any entity, relief agency or statutory body, for free distribution of such COVID - relief material for the purpose of this exemption (As per section 2 (103) of the Central Goods and Services Tax Act, 2017, State include a Union territory with Legislature).

In letter fourth read above, the Additional Chief Secretary / Commissioner of Revenue Administration has recommended that Thiru.V.Arun Roy, I.A.S., Special Secretary to Government, Industries Department may be appointed as the Additional State Nodal officer to authorize any entity, relief agency or Statutory body for the free distribution of COVID - 19 relief materials.

The Government after careful examination have accepted the proposal of the Additional Chief Secretary / Commissioner of Revenue Administration to appoint Thiru.V.Arun Roy, I.A.S., Special Secretary to Government, Industries Department as the Additional State Nodal officer to authorize any entity, relief agency or Statutory body for the free distribution of COVID - 19 relief materials and order accordingly.
